

TERMS & CONDITIONS

1. The Promoter is Victoria Racing Club Limited ACN 119 214 078, 448 Epsom Rd, Flemington, Vic, 3031. **(Promotor)**.
2. Information regarding how to enter and details of prizes forms part of these conditions of entry. Entry into this promotion is deemed to be acceptance of these conditions of entry.
3. Entry is open only to residents of Australia over 18 years of age that have purchased a ticket into 'The Peak' on the below days during the 2021 Melbourne Cup Carnival: **(Eligible Entrant)**.
 - Lexus Melbourne Cup Day, Tuesday 2 November 2021. 8:45am-6:50pm.
 - Kennedy Oaks Day, Thursday 4 November 2021. 10:40am-6:50pm.
 - Paramount+ Stakes Day, Saturday 6 November 2021. 10:40am-6:50pm

together the **(Promotion Periods)**.

Members and their guests will only be eligible for the individual day they have purchased tickets for and a separate promotion will be run on each day.

4. To enter the promotion, an Eligible Entrant is anyone who has purchased a ticket into The Peak on any one of the three days above (the Promoter will automatically exclude any person under 18 years of age). An Eligible Entrant will be randomly allocated to one of two teams to join the Promotion. Once the Eligible Entrant has been selected into a team, they will be on that team for the remainder of the Promotion Periods for the race day their ticket was purchased.
5. Once an Eligible Entrant has been registered into the Promotion, they will be given a ticket that recognises their involvement in the Promotion and can be used to redeem prize money (if any) at the end of the Promotion Period.
6. The total entry pool for each race day is \$15,000. This will be split between two teams and each team will be allocated \$7,500 each **(Entry Pool Kitty)**.
7. The Promoter will throughout the Promotion Periods, in its absolute discretion, place one or more bets, using the total value of the Entry Pool Kitty of each team, on races held during each race day at Flemington Racecourse or at another racecourse during the Promotion Period. The Promoter can reuse any winnings from a bet, and allocate as part of any future bets within the Promotion Period
8. At the end of the Promotion Periods, each team's Entry Pool Kitty (if any) will be equally distributed to all Eligible Entrants of each respective team in the form of cash payments. To the extent that the calculated amount payable to each Eligible Entrant is not an exact amount, the Promoter will round the amount up to the nearest \$5 increment (eg. \$43.45 will be rounded up to \$45.00). Any winning funds will be distributed from 10 minutes after "correct weight" is official after the last race at Flemington on each day of the Promotion Period. Members who leave earlier than this must contact VRC staff on the day and any winnings will be distributed as cash-on-card credits on their membership card. Member's Guests must remain after the last race to collect their winnings.
9. If TAB outlets are unable to provide cash to the value of the winnings, all members and guests will be contacted from Wednesday 10 November 2021 to provide banking details and winnings will be transferred by bank transfer.
10. The Promoter reserves the right to alter these terms and conditions without notice. The Promoter's decision is final and no correspondence will be entered into.
11. The Promoter will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this promotion, except for any liability
