

# **TERMS & CONDITIONS**

## **VRC Punters Club – SCPDDI 2021**



1. The Promoter is Victoria Racing Club Limited ACN 119 214 078, 448 Epsom Rd, Flemington, Vic, 3031 (**Promotor**).
2. Information regarding how to enter and details of prizes forms part of these conditions of entry. Entry into this Promotion is deemed to be acceptance of these conditions of entry. Entry is open only to residents of Australia over 18 years of age and VRC Members that register via the Promoter's website: <https://www.flemington.com.au/forms/punters-club>.
3. (**Website**). For the avoidance of doubt, a VRC member includes: Life, Full, Restricted, Young, Pre-79, Provisional, Absentee and a financial VRC member of the 2021/22 racing season (**Eligible Entrant**).
4. The Promotion commences at 11:00am on Spring Classics Preview Day, Wednesday 22 September 2021 and closes at 6:00pm on 22 September 2021 (**Promotion Period**).
5. The Promoter reserves the right, in their absolute discretion, to cease, suspend or cancel this Promotion, without notice, at any time.
6. To enter the Promotion, an Eligible Entrant complete the entry form on the Website. This includes providing your provide your full name and member number to the Promoter prior to the commencement of the Promotion Period.
7. By entering this Promotion, each Eligible Entrant consents to the Promoter that for any future 'Punters Club' promotion that the Promoter runs in an online (where no persons are permitted at Flemington Racecourse) manner, each Eligible Entrant will be automatically entered into that Promotion by the Promoter without further consent. For the avoidance of doubt, where the terms of this Promotion materially change, the Promoter will issue new terms and conditions and this clause 7 will not be applicable.
