## "GIDDY UP TRIVIA 2021" PROMOTION

## **TERMS AND CONDITIONS**

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents aged 18 years or over.
- 3. Employees, directors and other representatives of the Promoter and organisations involved in sponsoring or conducting the Promotion that are associated with the Promoter (and any individuals so involved) are ineligible, as are members of their immediate families and households.
