

TERMS AND CONDITIONS

2021/2022 MEMBER RENEWAL MEGA DRAW PROMOTION

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents aged 18 years or over who are current VRC Members in one of the following categories: Life, Pre-79, Full, Restricted, Young or Provisional ("Eligible Entrants").
- 3. Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 4. Entries into the promotion open on 14 July 2021 and close at 11:59PM AEST on 15 September 2021 ("**Promotional Period**").

Alternatively, if an Eligible Entrant has signed up to the Automatic Annual Renewal (Direct Debit) and paid for their VRC Membership Renewal in full during the Promotional Period or the Eligible Entrant is signed up to the Automatic Renewal Instalment Payment Plan and pay the first instalment during the Promotional Period, the Eligible Entrant will receive an entry into the draw.

- 6. Only one (1) entry is permitted per person.
- 7. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. In addition, winners may also be announced at the TAB Turnbull Stakes Day on 2 October 2021.
