

TERMS & CONDITIONS

VRC Punters Club –2022/23 season (excluding MCC)



1. The Promoter is Victoria Racing Club Limited ACN 119 214 078, 448 Epsom Rd, Flemington, VIC, 3031. **(Promotor)**.
2. Information regarding how to enter and details of prizes forms part of these conditions of entry. Entry into this promotion is deemed to be acceptance of these conditions of entry.
3. Entry is open only to residents of Australia over 18 years of age that have formally booked into 'The Peak' during the promotion period including VRC Members and their Guests **(Eligible Entrant)**.
4. The promotion commences at the start of Race 3 and closes after the 'correct weight' of Race 9 on each of the following race days excluding Melbourne Cup Carnival 2022 (Saturday 29 October 2022, Tuesday 1 November 2022, Thursday 3 November 2022 and Saturday 5 November 2022):

(Promotion Period).

5. To enter the promotion, an Eligible Entrant must pay a fee of \$20.00 **(Entry Fee)**, provide your full name and phone number (for Guests) or provide their member number (VRC Members) to the Promoter prior to the commencement of the Promotion Period. The Eligible Entrant will then choose one of two teams to join for the Promotion. Once the Eligible Entrant has selected a team, they will be on that team for the remainder of the Race Day they enter. Members and Guests are limited to a maximum of three entries per person.
6. Once an Eligible Entrant has been registered into the Promotion, they will be given a ticket that recognises their involvement in the Promotion and can be used to redeem prize money (if any) at the end of the Promotion Period.
7. A money back guarantee will be offered to Eligible Entrants on select race days as chosen by the Promoter, where if the result of each team is a loss, the Entry Fee will be refunded to the Eligible Entrants.
8. All Entry Fees will be totalled and used to form the basis of the Promotion **(Entry Pool)**. The Promoter will 'top up' each team's Entry Pool by \$500 at the beginning of the Promotion Period.
9. The Promoter will throughout each Promotion Period, in its absolute discretion, place one or more bets, using the total value of the Entry Pool of each team, on races held during the at Flemington Racecourse or at another racecourse during the Promotion Period. The Promoter can reuse any winnings from a bet, and allocate as part of any future bets.

10. At the end of the Promotion Period, each team's Entry Pool (if any) will be equally distributed to all Eligible Entrants of each respective team in the form of cash payments. To the extent that the calculated amount payable to each Eligible Entrant is not an exact amount, the Promoter will round the amount up to the nearest \$5 increment (eg. \$43.45 will be rounded up to \$45.00). Patrons must present their ticket and sign it to collect their winnings, this signing of the Eligible Entrant's entry ticket will be proof of collection of winnings for the Promoter. Any winning funds will be distributed from 10 minutes after "correct weight" is official after the last race at Flemington on each day of the Promotion Period. Members who leave earlier than this must contact VRC staff on the day and any winnings will be distributed as cash-on-card credits on their membership card prior to the next race meeting held at Flemington. Member's Guests must stay until after the last race to collect their winnings.
11. The Promoter reserves the right to alter these terms and conditions without notice. The Promoter's decision is final and no correspondence will be entered into.
12. The Promoter may, in its absolute discretion, decide to not run the Promotion any one or more of the race days listed during the Promotion Period.
13. The Promoter will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this promotion, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law). Eligible Entrants acknowledge and agree that they enter into this promotion at their own risk.
14. The Promoter will collect personal information from Eligible Entrants in order to facilitate the Promotion. Eligible Entrants personal information may also be provided to third parties (including prize suppliers) for the purpose of administering this Promotion.
