

## **“GIDDY UP SWEEPS 2021” PROMOTION**

### **TERMS AND CONDITIONS**

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents aged 18 years or over.
3. Employees, directors and other representatives of the Promoter and organisations involved in sponsoring or conducting the Promotion that are associated with the Promoter (and any individuals so involved) are ineligible, as are members of their immediate families and households.
4. Entries into the promotion open on 14 October 2021 and close at 1:00PM AEDST on 2 November 2021 for all entrants, and 1:00PM AEDST on 6 November 2021 for Eligible VRC Members (“**Promotional Period**”). All times are as applicable in Victoria.
5. To be eligible to enter, individuals must visit [giddyupflemington.com.au](http://giddyupflemington.com.au) and register an account during the Promotional Period. As part of the registration process, individuals will be required to confirm that they are aged 18 years or over and if applicable, enter their Victoria Racing Club (“**VRC**”) membership number. Only individuals who are financial members for the 2020/21 and/or 2021/22 racing season which includes life, full, pre 79, provisional, restricted, young, absentee full, absentee pre 79, absentee provisional and absentee restricted members (“**Eligible VRC Members**”) are eligible to participate in the Eligible VRC Members only portion of this promotion.
6. **All entrants:** To enter, individuals must log into their [giddyupflemington.com.au](http://giddyupflemington.com.au) account, select the sweeps competition from the main page and accept these Terms and Conditions before 1:00PM AEDST on 2 November 2021. Upon completing these steps, individuals will automatically be allocated a horse racing in the Lexus Melbourne Cup on 2 November 2021 at random, and notified of their allocation via email on the event day. Individuals who have been allocated a horse that finishes in first place, second place or third place will receive an automatic entry into the relevant draw. For removal of doubt, individuals whose horse do not finish in the top three places will not receive an entry into a draw.
7. **Eligible VRC Members:** Eligible VRC Members will have the opportunity to receive entries into additional draws. To receive an entry into each of the additional draws, Eligible VRC Members must log into their [giddyupflemington.com.au](http://giddyupflemington.com.au) account, select the sweeps competition and accept these Terms and Conditions during the Promotional Period. Upon completing these steps, Eligible VRC Members will automatically be allocated a horse racing in the Penfolds Victoria Derby on 30 October 2021; the Lexus Melbourne Cup on 2 November 2021; the Kennedy Oaks on 4 November 2021; and Mackinnon Stakes on 6 November 2021 at random, and notified of their allocation via email on the event day. Eligible VRC Members who have been allocated a horse that, according to Official Placings, finishes in first place, second place or third place in each of the events will receive an automatic entry into the relevant draw. Eligible VRC Members who have been allocated a horse that does not finish in the top three places will not receive any entries into a draw.

8. Entries into each event close at 1:00PM AEDST on the day of the event. While Eligible VRC Members can enter at any time during the Promotional Period, they will only be allocated a horse for the events taking place after the time they enter.
9. In the event that a feature race or a particular event is cancelled, abandoned, not completed or not conducted for any reason and/or a result is not officially declared within three (3) days of the date the race or event was originally scheduled to take place, individuals will not be allocated a new horse and will not receive any entries into the relevant draw.
10. In the event that an individual's allocated horse is scratched before the jump of the race, the individual will be allocated that horse's emergency replacement. In the event that an individual's allocated horse is scratched without an emergency replacement, does not finish the race or is disqualified for whatever reason before the of jump of the race, the individual will not receive a replacement horse and will not receive any entries into the relevant draw.
11. Only one (1) entry is permitted per person per race except for Eligible VRC Members who may receive one (1) entry into each of the Lexus Melbourne Cup draws depending on where their allocated horses finish.
12. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
13. Incomplete or indecipherable entries will be deemed invalid.
14. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
15. The Promoter's decision is final and no correspondence will be entered into.
16. **All entrants:** individuals who are allocated a horse that, according to Official Placings, finishes in first place, second place or third place at the Lexus Melbourne Cup will receive an entry into the relevant draw. Entries will be divided into three (3) groups: first placed, second placed and third placed horse of the Lexus Melbourne Cup. The first valid entry drawn from the first-place draw will win a cash prize valued at \$50,000. The first valid entry drawn from the second-place draw will win a cash prize valued at \$20,000. The first valid entry drawn from the third-place draw will win a cash prize valued at \$10,000.
17. **Eligible VRC Members only:** Eligible VRC Members who are allocated a horse that, according to Official Placings, finishes in first place, second place or third place at each of the events listed below will receive an entry into the relevant draw. Entries will be divided into three (3) groups for each event: first placed, second placed and third placed horse of the Penfolds Victoria Derby, Lexus Melbourne Cup, Kennedy Oaks and Mackinnon Stakes. Prizes will be awarded as follows:

- a) The first valid entry drawn from the first-place draw for the Lexus Melbourne Cup will win a cash prize valued at \$20,000. The first valid entry drawn from the second-place draw for the Lexus Melbourne Cup will win a cash prize valued at \$5,000. The first valid entry drawn from the third-place draw for the Lexus Melbourne Cup will win a cash prize valued at \$2,000.
  - b) The first valid entry drawn from each first-place draw for the remaining events will each win \$1,000 to be loaded on their VRC membership card. The first valid entry drawn from each of the second-place draw for the remaining events will each win \$500 to be loaded on their VRC membership card. The first valid entry drawn from each third-place draw for the remaining events will each win \$250 to be loaded on their VRC membership card.
18. For removal of doubt, all placings will be in accordance with Official Placings and not real-time placings.
  19. All draws will take place at Anisimoff Legal, Suite 5 210 Central Coast Highway, Erina NSW 2250 on 10 November 2021 at 9:00AM AEDST, in the presence of an independent scrutineer where required. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. Winners will be notified by telephone and email within two (2) business days of the draw. Winners will be published on <https://www.vrc.com.au/giddyup/terms-and-conditions/> from 24 November 2021.
  20. Cash prize will be awarded in the form of an EFT payment. Winners are responsible for providing full and accurate bank account details to the Promoter. The Promoter will not be responsible for a banking institution rejecting an EFT payment, or any costs associated with locating any lost monies.
  21. Subject to the unclaimed prize draw clause, if for any reason a winner does not take/redeem a prize (or an element of the prize) at/by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.
  22. If any prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.
